

**Checklist for Routine Repair and Maintenance Work on Special Use Permit Cabins
within the
Mineral King Road Cultural Landscape District, Sequoia National Park**

This checklist is to be used by cabin owners and the National Park Service (NPS) to document routine repair and maintenance work on the exterior of any of the cabins and their associated structures within East Mineral King, West Mineral King, or Cabin Cove.

Step 1: Before commencing any repairs or maintenance work on the exterior of any cabin, make a quick review of the guidelines prepared by the Mineral King Preservation Society (MKPS) and NPS to see what kind of work is "**Recommended**" and "**Not recommended**". See "*A Guide to Repair and Maintenance Of Historic Summer Homes Within The Mineral King Road Cultural Landscape District*" by Thomas Nave (2003). Contact either the MKPS or the NPS for a copy if needed (See contacts on back). "**Recommended**" work may be done without prior notification to the NPS. For other work, or if a project does not fit below, contact NPS archeologist Tom Burge (559-565-3139) to discuss what level of compliance is needed before work can begin.
